E. Discussion on 501C

Action of moving the Board and Officials to officially being known as TISDO and becoming a 501C was not able to be taken by Brian Walls during this year. Brian invited Attorney Korman to remain for our general meeting to advise on the requirements to become a 501C(3) Organization.

Attorney Dawn Korman's opinion is that we are not close to becoming a 501C(3) at this point. In her experience we need to re-write our by-laws and create a constitution to become a 501C(3).

Jim Holcomb will have a constitution ready to view by April 12th.

Gloria Schuldt will have the By-Laws by mid-May however they must still be approved by the Board.

Specify in the By-Laws that electronic voting may be used. The Constitution and By-Laws will be posted for all officials to see with a comment section.

3. A minimum of three officers are also needed to be a 501C(3). It was decided TISDO would have the following: Chairman, Vice-Chairman, Secretary, and Treasurer.

G. State Meet Review

Jim Holcomb: Swimming - Not as many officials signed up to work the State Meet this year therefore, all those who applied were used. Other than that the meet seemed to proceed well.

Penny DiPomazio: Diving - We had 43 officials apply. This was a large increase for us. The judging was much better and more consistent than in the past. The last event of the day is always the weakest judged event due to judges not being able to stay for the second session because they are coaches and their team leaves after the first session. The first session is always the easiest to get judges. There were a few issues, but all were resolved without incident.

H. State Rules Interpreter

Swimming: Jim Holcomb states that the backstroke ledge is coming. Six states have submitted the change and the NCAA has passed it. The NFHS normally follows the NCAA.

Diving: Penny DiPomazio states that there is a push to change the championship dive list to 11. Everyone she has spoken to is against it, and that information has been relayed to the NFHS.

I. 1204 update

Brian Walls states that what came out in 1204 legislation is not exactly what we wanted. It is more restrictive. A presentation to the legislative council will be needed to change it.

J. TISDO Website

Roger Graham will continue to be the webmaster for the site. Brian Walls has concerns as to what would happen if Roger Graham becomes incapacitated and cannot run the website. Roger Graham will give the Chairman the Username and Password in case there is an emergency situation.

UPDATE: Roger Graham says that the counter identifies users by IP addresses. Since January the site has had around 600 hits. We need to spread the word about the existence of this informative website.
