A few glitches in transition of account from UIL. Most of these were resolved after efforts by Schuldt and Walls. We have now received all our funds from the UIL. We anticipate a few growing pains as we transition onto the Arbiter platform. TISDO is on sound financial footing.

Still some discussion with UIL about payment of officials at state meet. However, next year (2019) full cost of state meet will be paid by UIL.We will revisit the payment of officials at the August meeting as well as the TISDO registration fee. Next season will be our first full year on the Arbiter platform and we are unsure, at this point, of some of our budgetary issues and are still in the process of firming those up.
